# SUPPORT TO CIVIL SOCIETY PROJECT

“Civil society is an essential element of democratic public life. Its active involvement in the process of political, social and economic reform in the Western Balkans strengthens democracy and reconciliation. Despite some positive steps, civil society organisations remain weak and need training to adapt to present circumstances. It is, therefore, important to create conditions conducive to further growth of their activities”, stated European Commission in its Communication on Western Balkans in 2008. (COM (2008) 127 final)

In October 2010, implementing the policy of the European Commission to further strengthening the civil society role on the Balkans, the Delegation of the European Union to the Republic of Serbia launched the Support to Civil Society project. It is part of the Civil Society Facility established in 2008 by the European Commission under IPA.

The project is implemented through a Call for Proposals, managed by the Delegation of the European Union in Serbia and implemented by GOPA Consultants.

## **The overall goal of the project is:**

To support active civil society participation in Serbia’s EU-integration.

AND ITS SPECIFIC OBJECTIVES ARE DEFINED AS:

### **Specific objective 1:**

Building social cohesion and overcoming discrimination in Serbian society by promoting tolerance and cultural diversity; and

### **Specific objective 2:**

Active civil society participation in the socioeconomic development.

# SUPPORT TO CIVIL SOCIETY CALL FOR PROPOSALS

The Call for Proposals has been published in December 2010, and closed in March 2011, generating high interest amongst Serbian, regional and EU-based civil society organisations, as over 280 applications were received. Upon evaluation, 43 actions were selected and awarded financial support. The details of these go-setting actions are to be found in this publication.

Non-governmental organisations, cultural foundations, associations of consumers, business associations and trade unions will work in partnership with other civil society organisations, cultural and educational institutions and local authorities from Serbia, the EU member states or other neighbouring countries to pursue their goals.

Cultural and educational institutions together with civil society actors will work on promotion of intercultural dialogue and cultural diversity and pursue the combat against discrimination. Music concerts, theatre plays, festivals of young contemporary writers and other location specific events will be organised to explore issues of concern in the region and make diverse communities known to the general public.

Age discrimination, quality standards in education and services sectors and mediation are some of the focuses of the supported actions.

Civil society organisations will also contribute to social inclusion in Serbia, by establishing and improving community based services for people with disabilities and applying public policies addressing homeless people and street children.

Together with local authorities, civil society actors will work to strengthen human resource capacities of rural tourism and to stimulate women entrepreneurship. Several actions will ensure the effective implementation of a number of well-planned local strategies, while others will contribute to the protection of Serbian environment and its 462 protected areas.

Consumer protection, prevention of harassment at workplace and enhancement of social dialogue are also within the objectives of the awarded projects.

Awarded projects are presented in two lots, in line with the Call for Proposals and the project objectives. Unless otherwise marked, implementing organisations and/or partners are from Serbia.

The grants awarded to civil society organisations amount to 4 million EUR and are from IPA 2009 and IPA 2010 programmes.

#### PROJECT DESCRIPTION

---

This project aims at overcoming **discrimination of elderly** in Serbia. It shall promote the concept of active aging, promote volunteerism amongst senior citizens and pursue support by the employers for the experience, knowledge and potential of elderly workers.

With an average age of 41.3 Serbia is on the 4<sup>th</sup> place on the list of ageing populations in the world.

The **activities** of this project include:

- 1) Campaign against age discrimination;
- 2) Research;
- 3) Training for unemployed elderly workers;
- 4) Conference on overcoming age discrimination at workplace and employment;
- 5) Workshops for volunteering of elderly, and
- 6) **Intergenerational dialogue** of elderly and young policy makers in local community.

The project strives to promote the **potential contribution of senior citizens to social growth** and workplace culture by focusing on the concept of active aging. It reaches to general public in Serbia, employers, unemployed older workers; senior citizens, young political activists, policy makers... and in particular will work to the benefit of elderly, employers, policy makers and civil society organisations that advocate for the elderly.

The results expected include:

- Reduced widespread negative attitudes towards ageing in population;
- Halted trend of dismissal and lower unemployment rate of people over 50 years and
- Alleviated **social exclusion** of pensioners.

The localities that the project will cover are Serbian cities **Belgrade, Niš and Kragujevac**, in duration of 12 months.

### PROJECT DESCRIPTION

---

The Well aims at generating public support for struggle against inequalities in Serbian society, using **culture and arts** as a tool. It shall work on a production of a **theatre play** titled "The Well", which promotes social and artistic values and speaks against gender discrimination, family violence and regressive attitudes that hamper development. Particular outreach will be done to attract **young people** to attend theatre performances and culture, arts and tolerance will be debated with audience after the performances.

The project reaches to theatre public in **Belgrade and other towns in Serbia** and in particular towards young generations. It aims at creating benefits for women, victims of family violence, and youth.

In 8 months, the following results are expected:

- 1) Raised citizens' awareness about the existing intolerance, discrimination and violence and generated **public support to fight inequalities** and violence through performance of a theatre play, debates and through culture in general;
- 2) Promotion of cultural events that promote social and have **high artistic values** and are not made for profit only;
- 3) Young people's interest for culture and arts is increased;
- 4) **Channel for debating culture** and arts as means to influence social development is created.

The activities include production and performances of a theatre play; outreach to potential public and debates on **interlinks between Culture, Theatre, Arts and Tolerance** and include cooperation between the artists of former Yugoslavia countries.

Torn by ethnic prejudices and stereotypes, the main characters are being rejected by the community for the single fact that their parents belonged to different ethnic communities. The main plot of the drama is initiated when plans are made to construct a new water supply system in the community, but the community is not willing to accept this novelty...

# Ecumenical Humanitarian Organisation implements Enhancing Social Cohesion by Developing Non-Discriminative Policy for Street Children project

## PROJECT DESCRIPTION

---

Project works in collaboration with the Novi Sad University to increase public debate on the situation of **street children** through development on **non-discriminative policy** for this target group. It reaches to policy makers, media, state representatives and civil society. The action will last for 12 months and primarily be located in the city of Novi Sad in Serbia.

The **activities** include:

- 1) **Field research** on Roma settlements,
- 2) Public campaign combating inequality of street children and
- 3) Coalition building to advance **the social status** of these vulnerable groups.

In the last two Progress Reports on Serbia, the European Commission reports that legally invisible people in Serbia, including the street children, face high social exclusion.

The aim is:

- to increase knowledge on **social inequality and existing discrimination** by collecting data about street children,
- to increase **visibility of street children** in the Provincial public by raising awareness and mobilizing community support,
- To contribute to **overcoming existing social inequality** by drafting and submitting non-discriminative policy.

... Street children are a group which has multiple vulnerabilities. In Serbia, more than 90% of them are Roma, extremely poor, uneducated and without parental care and protection. In addition to all those vulnerability factors, or maybe because of them, they are very often victims of discrimination, frequently accompanied with physical violence...

### PROJECT DESCRIPTION

---

Project addresses **intellectuals, artists, politicians, public figures, opinion makers, ethnic and religious community leaders**, and includes organisation and performing of five concerts of classical music followed by the "behind the scene" documentary film. The concerts will depict cultural diversity as they will be tailored to **celebrate Jewish, Muslim, Catholic and Orthodox** New Year's Eves. The final concert will feature inter cultural musical content of 4 major religious communities in Serbia. The project will last for 9 months.

The project aims at:

- 1) Enhancing public knowledge for **cultural diversity** through cultural media production and cultural events;
- 2) Increasing the inter-cultural dialogue among different communities;
- 3) Increasing public understanding of **cultural pluralism** and;
- 4) Improving regional cultural cooperation.

Concerts will be performed by **Belgrade's Philharmonics Orchestra** and will also be broadcasted at the national television. By performing traditional music of four major religious communities in Serbia, cultural pluralism and public general understanding of cultural diversity will be enhanced and promoted.

... We believe that different calendars can serve as a starting point for a dialogue and cultural exchange, and that in this way these sensitive issues can be addressed without much dispute and adverse reactions they often inspire. Using New Year, which symbolises a new beginning, we create a positive atmosphere in which diversity is considered to be an advantage, a precondition for mutual understanding within a civil society, a basis of its polyvalence and a measure of the society's creative potential...

## PROJECT DESCRIPTION

---

This project aims to move up solidarity in diversity through knowledge and art production. It reaches to researchers, artists, students and volunteers that are active in the domain of culture and arts and will work to the benefit of cultural institutions, NGOs, universities and research institutes, art initiatives, media groups, artists, cultural workers, academics, teachers, activists and public in general.

Its objectives are to:

- 1) Strengthen connections, communication and joint work between civil society actors and agents of culture and art in Serbia and the region.
- 2) Foster new public remembrance by crafting a link to the memory inside the re-contextualized public space;
- 3) Explore patterns of solidarity in diversity through knowledge, culture and art;
- 4) Introduce agents of social changes through new politics of equality and solidarity in diversity.

The main activities include preparation and carrying out of four cultural events:

- **One Flew Over the Parties' Nests**, a site-specific performance created in co-production of Centre for Cultural Decontamination from Belgrade and Qendra Multimedia from Pristina; which will try to seek the public ownership over the public places,
- **Four Faces of Omarska**, a three-day site-specific event consisted of public readings, workshops and interactive round tables covering the past and recent history of this troubled location in Bosnia and Herzegovina;

- **Trip to Russia**, a theatre play depicting the vision of citizenship by seminal Croatian writer, Miroslav Krleža, and
- **Through a Glass, Darkly**, an exhibition of archived audio and visual documents gathered throughout the project.

The project activities will take place in Serbia, Kosovo UN1244, Croatia and BiH, more specifically in Belgrade, Zagreb, Pristina and Tuzla, in the duration of 12 months.

## PROJECT DESCRIPTION

---

This project will work in the localities of Belgrade, Niš and Novi Sad in Serbia and contribute to social cohesion by undertaking research, advocacy, awareness raising and policy making on **homelessness**. The specifics of social exclusion of homeless people in Serbia will be studied and public dialogue and research of relevant EU practices will support making of the **more adequate policy answers**.

About 18% of apartments in Serbia are overcrowded and 8% severely overcrowded (more than three people share the same room for living).

The activities aim at reaching to policy makers, CSOs and local authorities to the benefit of people living in the situation of rooflessness, houselessness, those living in insecure and also those living in inadequate accommodation.

The **activities** of the project include:

- 1) Research,
- 2) Awareness raising and media campaigns,
- 3) Conducting multi-sector dialog and formulating the recommendations for policy shaping.

This will result in:

- Gathered and analysed knowledge on homelessness in Serbia
- Establishment of cross-sector dialog on homelessness
- Agreement on definition on homelessness
- Formulation of recommendations for new inclusive policies and strategies on homelessness

... Authentic personal stories of the homeless in Serbia, emphasizing their wishes and proposals for overcoming the problem of social exclusion shall be a very important part of the project. The voice of the homeless shall be clearly heard at the round tables and press conferences and their suggestions shall be included in the proposals and recommendations resulting from this project...

**PROJECT DESCRIPTION**

This project aims at finding solutions for **civil registration** of people residing in informal Roma settlements in Serbia. It focuses on the **right to be recognized as a person** before the law and also on the **right to enjoy adequate housing**. It will raise public awareness on the indirect, administrative discrimination of Roma population in Serbia. The project will use its 10 months to target government officials, policy makers, local self-government officials, international and domestic experts, civil society organizations and general public **to the benefit of Roma population in Serbia**, specifically those who are not registered in birth registry books and reside in informal settlements.

Drawing attention to “legally invisible people”, as the right to be recognized as a person precedes access to any other right.

The project will result in:

- 1) Domestic and European experts in civil registration and right to adequate housing taking active part in the process of finding solutions for the issues;
- 2) Identification of **good practices in the countries of EU** applicable to Serbian context;
- 3) Obtained knowledge, experience and recommendations for improvement of **legal framework, administrative procedures and services**.
- 4) Increased **awareness among general and expert public** regarding discrimination of Roma.

... People who are not registered in birth registry books find themselves outside the system of health care, social welfare and employment; they are socially excluded and exposed to various forms of discrimination in Serbia...

This project will cover the cities of Belgrade, Novi Sad, Užice, Leskovac and Bor and strive to **improve the attitude towards the elderly in the Serbian society**. It will work with local authorities and civil society organisations to the benefit of the senior citizens of Serbia and focus on photo contest and mobile exhibition which portrays elderly in a positive, contributing and refreshing image.

The expected results include:

- 1) Reduction of prejudices and stereotypes and an increased appreciation of the elderly,
- 2) Growing interest and readiness to engage in community activities for, about and with the elderly.

## PROJECT DESCRIPTION

---

This project undertakes an effort **to mainstream antidiscrimination policy in the sphere of education sector** by taking legal action, educating, raising awareness level and contributing to creation of regulatory framework. Special focus is placed on **educational inspectors and advisors**, who have an institutional role in ensuring quality and effectiveness of the education system.

Well drafted by-laws of the Law on the Fundamentals of Education System will enable mainstreaming of anti-discrimination policy in the education system.

The project will work with high-school students, educational inspectors and advisors, school management, teachers and psychologists to the benefit of the improved education system.

The expected results include:

- 1) Raised awareness level of the target groups,
- 2) Number of tailored workshops and training sessions held,
- 3) **Strategic (legal) cases of discrimination** initiated in front of relevant institutions and court and
- 4) **Production of inputs for bylaws regulating** education system, and in particular antidiscrimination mechanisms within it.

... Discrimination is still widespread in Serbia against a number of vulnerable groups, including displaced persons, refugees, people with physical and intellectual, Roma, national minorities, LGTB population, etc. Nevertheless, it is children within each of these groups that seem to be a particularly defenceless target...

## PROJECT DESCRIPTION

---

This project will cover the cities of **Novi Sad, Subotica, Beograd, Kruševac, Leskovac and Niš** and work on promoting **full and effective participation and inclusion** in society of people with disabilities. It shall target employers, including media, CSOs and SMEs and employment agencies **to the benefit of people with disabilities.**

The main **activities** include:

- 1) Radio shows, public events and web portal
- 2) Technical assistance aimed at ensuring accessibility of people with disabilities to workplaces
- 3) Award of **accessible employer certificates** to those implementing new practices

The expected outputs include:

- 1) **Training** to people with disabilities to ensure employability,
- 2) Consultancy to companies to **ensure accessible workplace,**
- 3) Liaison with National Employment Agency and preparation of technical documentation for **workplace adjustments.**
- 4) **Involvement of public figures from culture and sports** in the promotion of accessibility of workplaces.

Employers have the opportunity to claim benefits when employing people with disabilities in Serbia, in the form of co-financing of the workplace adaptation costs and/or salary subsidies. However, they are often discouraged by complicated administrative procedures.

... Accessibility is an essential attribute of a people-centred, sustainable environment... Employers are reluctant to give a job to a disabled person due to their ignorance, lack of information, and fear from their disabilities. Therefore, they need to be provided with an additional information and training. Wider public also needs the information on abilities and competencies of disabled persons in order not to segregate and discriminate them. As their potential co-workers, they need to have a proper information on what disabled persons are able to do and how they need to be treated in a work place and in everyday life...

- Research on farm animal welfare state, including methodology draft and knowledge transfer;
- Assessment of situation of farm animal welfare at national and local level;
- Drafting of Code on Farm Animal Welfare Standards;
- Drafting and production of an Action plan for Farm Animal Welfare Standards in Sremska Mitrovica.

### ANIMAL WELFARE

The **Treaty of Lisbon**, which entered into force on 1 December 2009, incorporates an article on animal welfare, in which it instructs all EU institutions and Member States to "pay full regard to the requirements of animal welfare" in the EU's competent areas.

The **Council Directive 99/74/EC** of 1999, gives Member States 2012 as the deadline to ban battery cages for laying hens and replace them with "enriched cages" that must include increased space allowances, claw shortening devices, perches, nest boxes and litter for scratching and pecking.

... Animal welfare is recognized as a core component of a responsible livestock sector. It is integrated in programmes that improve animal health, increase livestock productivity, respond to natural disasters where animals are involved, and used as framework when the fit between the genetic makeup of animals and the environments in which they are kept is being defined...

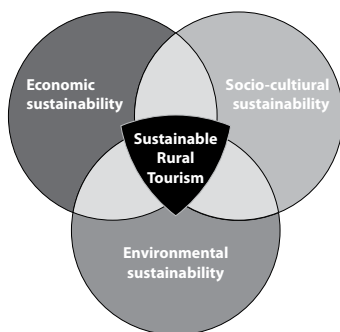

## PROJECT DESCRIPTION

This project works with **locally based services providers** that work on raising employability of people with disabilities. It aims at involving local and national authorities in the dissemination of the models of good practice **in employment of people with disabilities in Serbia**. At seven localities, services and actions will be implemented to support/employ people with disabilities, **including small scale income generation actions**, day care centers and **independent living services**.

The expected results of the project include:

- 1) Production and promotion of **local models of good practice** in employment of people with disabilities (PWD) in Serbia, based on EU/Dutch models;
- 2) Increased capacity of CSOs for advocating for local PWD employment policies;
- 3) Improved **networking** of CSOs in Serbia around national policy for PWD employment and achieved **open dialogue** with national institutions and businesses;
- 4) Increased PWD employment in Serbia and decreased discrimination in the society.

### NEW LEGISLATION

The new Law on Social Protection of Serbia provides possibility for development of programs aimed at the improvement of social services at the local level, and measures and activities for the development of new, innovative services at local level are foreseen.

## PROJECT DESCRIPTION

This project contributes to active civil society participation in the socioeconomic development **through fight against corruption** and implementation of anti-corruption public policies and EU standards at local level. It includes activities that build capacities of local public, business and non-governmental sector for design and implementation of **measures for reduction of corruption at local level** and aims at **establishment of local cross-sector partnerships and anti-corruption networks**.

Particular focus is placed on civil society inclusion in **Local Action Plans for Fight Against Corruption** in six local communities from six regions of Serbia.

The **objectives** of the action are:

- 1) to develop sustainable and efficient methodology and model for fight against corruption on a local level and their **public advocacy**;
- 2) to ensure greater transparency, openness and **accountability of public administration** at local level by pilot implementation of developed local action plans;
- 3) to build **capacities of local public, business and non-governmental sector** for design and implementation of measures for reduction of corruption on a local level;
- 4) to establish local **cross-sector partnerships** and networks for organised fight against corruption;

... Local Action Plans for Fight against Corruption will include minimum of information which are needed for obligatory integrity plans of public institutions, such as:

- Assessment of exposure to corruption for particular local institutions;
- Description of the work process, decision making procedures and identification of activities that are particularly exposed to corruption;
- Preventive measures for the reduction of corruption;
- specific issues which are particularly relevant for the local community and the region, (e.g. state subsidies to agriculture, social welfare, licences, assistance to refugees, employment, health care, etc.)...
